Persons within the city limits may use or otherwise discharge permissible fireworks provided the following conditions are met:

- 1. No city, county or state burn ban is currently in effect;
- 2. Discharge of fireworks occurs on private property or as indicated in the permit;
- 3. An adult who is responsible party must be present at all times during discharge, removal and extinguishment of debris;
- 4. Discharge occurs on July 3rd, 4th, or 5th between the hours of noon and 11:59 PM;
- 5. Discharge occurs on a non-combustible surface and safe distance from any property that would pose a risk of injury, property, or unintended fire. Ready access to water hose, bucket of water, or fire extinguisher shall be available during discharge of fireworks;
- 6. Responsible party must ensure all debris is removed and extinguished in a safe manner;
- 7. Any person discharging fireworks shall have on their person a copy of their city permit, or display said permit in a visible location so that it may be inspected easily by city officials.
- 8. Persons may not use or discharge fireworks within any city park, nor on any highway, turnpike, street, or roadway.
- 9. Responsible party obtains a consumer fireworks display permit and pays the permit fee in the amount of \$25.00 per location for the calendar year in which the permit is issued.

Failure to comply with any of the foregoing provisions and/or any violation thereof shall constitute an offense punishable under Section 1-108 of the Sapulpa City Code. Each day any such provision is violated shall constitute a separate offense.
