Dear Mr. Pettit:

On January 12, 2017; June 20, 2017; September 7, 2017; and November 3, 2017 the City of Sapulpa was issued the above-mentioned Notice of Violation ("NOVs"). These NOVs required the City of Sapulpa to comply with the requirements of the Oklahoma Administrative Code, Rule 252:631-1-3 of the "Public Water Supply Operation" rules, and distribute public notice to the users of the water supply.

A review of Oklahoma Department of Environmental Quality ("DEQ") records confirmed that the system's current sample result(s) have fallen below the MCL, and the system has met the compliance criteria for those violations. In addition, the City of Sapulpa issued the required public notices for these NOVs, and all proofs of public notice certification were submitted to DEQ. Therefore, the above-referenced NOVs are closed as of the date of this letter.
