Police Chief Mike Hefner reported that three companies have provided proposals for a CAD system to be used by the Police Department and Fire Department: PTS Solutions, Tyler Technologies and Spillman/Motorola. The costs for each proposal were discussed.

According to both Police Chief Mike Hefner and Fire Chief David Taylor, the Spillman/Motorola product will meet the current and future needs of both departments. Spillman/Motorola's CAD system is currently being used by Rogers County, and the City of Bethany has had the software for over twenty years.
