#### 1. MINUTES.

**A.** Motion was made by Mr. Lou Martin, seconded by Mr. Hugo Naifeh, to approve the minutes of the December 12, 2018, Administration and Finance Committee meeting.

#### 2. ADMINISTRATION.

City Manager Joan Riley presented to the committee a preliminary renovation and needs assessment list for the Booker T. Washington Community Center. The renovation list totaled \$236,500.00 with costs possibly being higher. The fixtures and furniture list costs was in the amount of \$35,800.00. A new community center may need to be considered.

The city manager also presented to the committee a list of potential projects for funding with General Obligation Bonds. The categories presented for funding totaled of \$32,638,731.00: Public Safety - \$5,000,000; Route 66 and Downtown Revitalization - \$6,900,000.00; Community - \$8,500,000.00; Economic Development - \$2,750,000.00; Park and Recreation - \$9,488,731.00. Other possible capital considerations which may need to be considered for funding was in the amount of \$750,000.00.

Repayment of the bonds would require an 18 mill levy with a twenty-five year G. O. Bond term. Possible election dates for this year would be the months of September, 2019, or December, 2019.

No action was taken by the committee.

A. According to City Manager Joan Riley, problems with the concessionaire at the golf course continues. Staff is working to resolve the issues.

No action was taken by the committee.
